 20 Notice of Exemption from CEQA, Pub. Res. Code § 21000, et seq., prepared by respondents in
 21 support of their approval of the regulation amendment to Title 17, CCR §30253 (R-31-98)
 22
 23 2. Respondents are ordered to set aside their approval of the regulation amendment to Title 17,
 24 CCR, §30253(a), insofar as it incorporated by reference, adopted, and modified Subpart E of
 25 Part 20, Code of Federal Regulations, Title 10, §§ 20.1401 -20.1406.
 26 3. Respondents in the above-captioned case are ordered not to readopt the radiological criteria
 27 for license termination set forth in 10 CFR §§ 20.1401 -1406, or any similar provisions relating
 28

1 to the establishment of clean-up standards for license termination, without first preparing ~~the~~ ⁶⁻¹⁷⁻⁰²
2 ~~conducting~~ an EIR in compliance with CEQA, Pub. Res. Code § 21000 et. seq.
