Dear Ms. Stringham,

Again, thank you for your prompt and responsive reply.

As you suggested, I am attaching a completed "Request for Public Records" form that reiterates the original May 20, 2023, records request but extends the time period to today.

Your concluding remarks that there were no records of the investigation to be found, other those already in my possession, is troubling and implies that no investigation was done. I am reminded of the old engineers' adage, "if it's not written down, then it didn't happen." I guess these days one should amend it include "... written or videoed ..."

The May 16, 2023, WMRC letter states, "The inspectors conducted interviews and reviewed documents, including waste manifests." Where is the documentation that that happened?

The May 16, 2023, WMRC letter states, "... the Division investigated the issues outlined in your letter ... the Division has determined that waste shipments ... are in compliance with the Clive Waste Acceptance Criteria ..." In my February 9, 2023, letter (with online links) to WMRC, I provided extensive written proof that widespread data in NRC 540/541 manifests were systematically and intentionally falsified. This was not an issue of occasional, unintentional errors. Where is the documented written evidence that WMRC disputes these allegations and proves me wrong? You say that you cannot find any further records of the investigation. Therefore, that implies that there is no documented evidence to support WMRC's statements in its letter. If this was litigation, WMRC's lack of evidence, would not be a good position to be in.

I realize that you personally are not responsible for this lack of evidence of an investigation.

Mr. Rutherford,

Your appeal will be directed to the Division's Chief Administrative Officer.

I'm very sorry that the emails didn't make it to your inbox! We've found that it's best to have one GRAMA email inbox so all of the Division's records officers can all have delegated access to it and be able to work on incoming requests and responses in the same place, and that way they don't get stranded in an individual's inbox during an absence. Hopefully now that you've added the address, there won't be any more issues receiving them.

Given the amount of time that's passed since the response, I recommend that you submit a second records request. I've attached DEQ's GRAMA request form, and after you've filled it out you can submit the completed form to [wmrcgrama@utah.gov](mailto:wmrcgrama@utah.gov).

I also want to apologize for the confusion about the statement "*Pursuant to GRAMA, Utah Code § 63G-2-201(8)(a), a governmental entity is not required to create a record in response to a request. Therefore, with the attached records, the Division considers your records request to be granted and fulfilled.*" This was intended to address that the Division had not created additional records in order to have more records to be considered responsive to your request, such as a memo or note to file to serve as "documentation of DWMRC investigation resulting from my February 9, 2023 letter," especially since I didn't identify any records beyond the ones that were already provided by you or to you. It was not intended to omit records that already existed in the Division's possession, and I'm sorry it came across that way.

If there had been records identified in the records search that were not provided to you, my typical process as the Record's Officer is to deny those records to you and then identify those denied records to you with the following information for each: a brief description of the responsive record that has either been withheld or redacted in part, the reason for the denial/redaction, and the applicable GRAMA citation for the denial/redaction. Then, I would acknowledge the denial in the response to you and provide information for you to appeal any determinations the Division made regarding your request. As stated in the response, "The Division's search did not identify any records responsive to this request..." therefore there were no records to be denied to you.

Dear Ms. Stringham,

Thank you for your prompt response. Your resending of the June 6, 2023 email from SHWGramma SHWGramma <[wmrcgrama@utah.gov](mailto:wmrcgrama@utah.gov)> did indeed end up in my spam folder, so I assume that the same happened when it was originally sent. In contrast, your emails from [astringham@utah.gov](mailto:astringham@utah.gov); on behalf of; SHWGramma SHWGramma <[wmrcgrama@utah.gov](mailto:wmrcgrama@utah.gov)> do appear in my inbox. I have subsequently flagged SHWGramma SHWGramma <[wmrcgrama@utah.gov](mailto:wmrcgrama@utah.gov)> as being a safe email address, so hopefully possible future emails will not go to the spam folder.

The four attachments that were included were email and mail communications between myself and WMRC, which of course I already possess. The records request was for documentation on the complaint investigation itself. This was made plain in the public records request. I therefore do not regard the four communications as responsive.

I note your statement,

***"Pursuant to GRAMA, Utah Code § 63G-2-201(8)(a), a governmental entity is not required to create a record in response to a request. Therefore, with the attached records, the Division considers your records request to be granted and fulfilled."***

I respectfully disagree. The implication that Utah law does not "require" WMRC to "create a record" does not imply that records were not generated and/or kept. Any organization, whether commercial or governmental, cannot function without a robust document management system. This is especially true for a regulatory agency. Your reluctance to provide documentation of the investigation belies the whole intent of an open and transparent public agency, and the very existence of Utah's Public Records Portal. Please consider this email as a Notice of Appeal.

Subsequent to the original records request of May 20, 2023, a telephone conversation with Mr. Otis Willoughby and Mr. Larry Kellum occurred on May 23, 2023, in which I pointed out that WMRC's decision to close the investigation, based on the fact that greater than Class A waste had not been transferred to EnergySolutions, was not at issue, and was not the basis of the complaint. The allegations of my complaint were not addressed at all. Mr. Willoughby committed to take a second look at the complaint and attempt to address the issues of the complaint. See attachment. Is it possible to extend the original records request from the original end date of May 20, 2023, to today's date, in order to capture any investigation documentation subsequent to our May 23, 2023, telephone conversation? If I need to submit a second document request, I can do so.

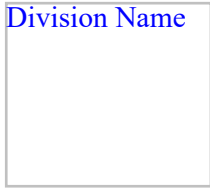

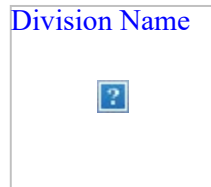
